
ABOUT OUR FIRM


AUDITING & ASSURANCE


TAX

Funaro & Co. has successfully assisted numerous clients in connection with Transfer Pricing examinations and the negotiation of Advance Pricing Agreements.






TAX VALUATION & TRANSACTION ADVISORY SERVICES

The services include, but are not limited to, taxable reorganizations, net operating loss limitations (Internal Revenue Code Section 382), asset allocations for tax purposes and the valuation of inventory, fixed assets, intangible assets, and goodwill/going concern (Sections 338 and 1060), discharge of indebtedness (Section 108), "golden parachute" payments/non-compete agreements triggered by change of control transactions (Section 280G), interest expense allocation between U.S. and foreign sources (Sections 861 and 864), worthless stock deductions (Section 165) and transfers of appreciated property to non-U.S. entities to determine the extent of gains that may be triggered as a result of the transfer (Section 367).


